Community Action Coalition for South Central Wisconsin (CAC) has been operating the WISH program in Waukesha County for several years. This year, WISH ranked 5 out of 39 Balance of State programs. Our program ranks high because of the consistency of our clients maintaining housing, our intensive case management, partnership and relationship building with landlords, and the collaborative efforts of area programs working together to overcome barriers. We are committed to continuing to improve and grow this program. CAC has received and administrated numerous types of federal funds including HUD funding and USDA funding for many years to provide housing and food security programs. CAC has been serving the housing needs of Waukesha County since 1996. In the past year of running the WISH program, we have helped 11 individuals with a disability get into and maintain stable housing. 1 of these individuals was chronically homeless and had been homeless for 19 years. CAC's long history in Waukesha County means that we have the partnerships and connections needed to find individuals in need and the history of success to cause them to trust us.

2. Describe your organization's (and subrecipient(s) if applicable) experience in leveraging Federal, State, local and private sector funds.

CAC currently utilizes Community Services Block Grant funds to provide match for our WISH program. CAC currently receives funding from Federal, State, local, and private sector sources. Potential matching funds are identified by locating private foundations/corporations whose giving goals align with our mission and staying up to date on government agency funding opportunities via their newsletters and grants.gov. CAC is always seeking out new funding sources.

1. Provide a description that addresses the entire scope of the proposed project.

Once a participant is identified, a CAC Caseworker will work with them individually to locate permanent housing. The Caseworker will utilize existing landlord relationships and create new relationships as needed to help clients access these opportunities. WISH is a PSH program that works with and assist households with rental assistance and intensive case management for as long as they qualify for the program. CAC Caseworkers can provide services such as budgeting assistance, referrals, and social service enrollment assistance. Caseworker intervention is aimed at helping these individuals stay in permanent housing options after exiting the program. This expansion proposes funding for five more chronically homeless individuals in permanent supportive housing receiving supportive services. WISH participants are identified from the Coordinated Entry list maintained by the Housing Action Coalition. Coalition members are also referral partners for our clients. Through the supportive services provided to WISH participants, CAC can refer clients to other agencies as needed. These may include federal/state programs such as FoodShare or Wisconsin Department of Workforce Development or county services such as county Waukesha County Human Services. CAC also maintains numerous relationships with local non-profits such as Hebron's House, a local housing services agency, or The Women's Center a resource center for those dealing with abuse, domestic violence, and/or human trafficking. COC bonus funds will be used to fund the lease of 5 1-bedroom units and supportive services for 5 new individuals. A portion of the funding will also be used to cover operating and administration costs.

WISH will use Coordinated Entry to locate chronically homeless individuals with at least one disability with the highest need for enrollment into the WISH program. Caseworkers will work closely with clients to determine what their greatest needs are after housing has been secured and refer them to other resources as needed. WISH serves those that face significant barriers to entry, specifically chronically homeless individuals with a disability. Our WISH Caseworkers first priority is to get our clients into permanent housing. To that end, Caseworkers will lean on existing relationships with landlords or work to create new relationships if needed to give our clients the best chance of getting into and staying in housing. Caseworkers will then begin more intensive case management including budgeting assistance, referrals, and barrier removal support to help our clients increase their income sources and maintain housing. CAC will identify appropriate housing opportunities based upon our client's location, current financial status, and projected financial status after exiting the program. We want to get our clients into housing that they are most likely to be able to afford after exiting the program. Caseworkers provide intensive case management including budgeting, landlord mediation, resource referrals, housing counseling, and more. CAC has extensive partnerships that enable us to refer our clients to employment resources, mental health services, food pantries, and other state/local/non-profit resources.

2. Describe the specific plan to coordinate and integrate with other mainstream health, social services, and employment programs for which program participants may be eligible.

Caseworkers will refer clients to services such as Latino Academy of Workforce Development, Wisconsin Department of Workforce Development, Wisconsin Works, and FoodShare Employment and Training for workforce development and employment services. CAC has existing relationships with these organizations that make it easier for us to help our client connect with these programs. These programs can help clients gain higher paying employment that increases their chance of exiting the program into permanent housing. CAC Caseworkers will help clients apply to programs such as food stamps, veteran benefits, WIC, and WI shares. We connect clients to ADRC. United Healthcare, or provide information on free local clinics for healthcare. We are also working on staff becoming SOAR certified.

New in FY2023, the Violence Against Women Act (VAWA) has clarified the use of CoC Program funds for VAWA eligible cost categories. These VAWA cost categories can be added to a new project application to create a CoC VAWA Budget Line Item (BLI) in e-snaps and eLOCCS. The new BLI will be added to grant agreements and utilized the same as other CoC Program BLIs in e-snaps and eLOCCS. Eligible CoC VAWA costs can be identified in one or both of the following CoC VAWA categories. Examples of eligible costs in these cost categories are identified as follows:

A. VAWA Emergency Transfer Facilitation. Examples of eligible costs include the costs of assessing, coordinating, approving, denying, and implementing a survivor's emergency transfer(s). Additional details of eligible costs include:

- Moving Costs. Assistance with reasonable moving costs to move survivors for an emergency transfer(s).

- Travel Costs. Assistance with reasonable travel costs for survivors and their families to travel for an emergency transfer(s). This may include travel costs to locations outside of your CoC's geography.
- Security Deposits. Grant funds can be used to pay for security deposits of the safe unit the survivor is transferring to via an emergency transfer(s).

- Utilities. Grant funds can be used to pay for costs of establishing utility assistance in the safe unit the survivor is transferring to.

- Housing Fees. Grant funds can be used to pay fees associated with getting survivors into a safe unit via emergency transfer(s), including but not limited to application fees, broker fees, holding fees, trash fees, pet fees where the person believes they need their pet to be safe, etc.
- Case Management. Grant funds can be used to pay staff time necessary to assess, coordinate, and implement emergency transfer(s).
- Housing Navigation. Grant funds can be used to pay staff time necessary to identify safe units and facilitate moves into housing for survivors through emergency transfer(s).
- Technology to make an available unit safe. Grant funds can be used to pay for technology that the individual believes is needed to make the unit safe, including but not limited to doorbell cameras, security systems, phone, and internet service when necessary to support security systems for the unit, etc.
- B. VAWA Confidentiality Requirements. Examples of eligible costs for ensuring compliance with VAWA confidentiality requirements include:
- Monitoring and evaluating compliance.
- Developing and implementing strategies for corrective actions and remedies to ensure compliance.
- Program evaluation of confidentiality policies, practices, and procedures.
- Training on compliance with VAWA confidentiality requirements.
- Reporting to CoC Collaborative Applicant, HUD, and other interested parties on compliance with VAWA confidentiality requirements.
- Costs for establishing methodology to protect survivor information.
- Staff time associated with maintaining adherence to VAWA confidentiality requirements.
