3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

This PSH Program will provide permanent housing, intensive case management & supportive services to single adults & families who have a disability & are experiencing chronic homelessness and prioritized using the BoS prioritization list for singles, families & the non-HMIS list. Utilizing housing first, CAI proposes to continue offering 12 scattered site rental units between Rock & Walworth Counties without a designated length of stay. As openings become available those prioritized will be contacted to update their homeless status. If the household is still in need of housing, they will be offered the program and scheduled to meet with the coordinator to confirm chronic homelessness & disability. Participants will be guided through the enrollment process that includes finding a unit that is appropriate for household size, meets FMR & rent reasonableness standards. Each household enrolled will have 30 days to locate a unit that meets required standards. If a unit is not secured in this time frame, an extension can be given. Once a unit has been identified, landlord agrees with program requirements & unit passes an HQS Inspection the participant may proceed with a lease signing in coordination with CAI as the primary lease holder. The program will pay a security deposit & up to 100% of the monthly rent as determined by the household's adjusted gross monthly income. Case management services will be offered to the participant on a regular basis as determined by the individual's service plan. Case management may include, but not limited to, assessing, planning, coordinating, implementing, & evaluating the overall services delivered; connecting with mainstream resources; & support in learning to live in housing independently & assisting in the creation of support systems within the community should they choose. CAI coordinates with other agencies in our service area such as ECHO, Food Pantries, School Liaisons, employment services, county human services departments & healthcare service providers. We complete a mainstream resource form & refer to any agency that may be able to provide assistance. Examples: ECHO-has a RRH program, work together when pulling for openings, make referral to their food pantry. Healthcare- Compass's project connect, Rock County CCS, My Choice, and HealthNet-refer for services. Rock County CCS-joint home visits, coordination of mental health services. School Liaisons-they refer homeless to us, we refer households to them for transportation assistance. Human services-CPS-support team meetings. Take people to job center to work on resume and look for jobs. DVR-refer individuals & provide transportation to their initial appointments. Everyone's service plan will be client centered & acceptance of the services offered is not a condition for continued housing assistance. CoC funding is needed to allow us the ability to serve the chronic homeless population in our communities. The decline in the number of chronically homeless families on the prioritization lists makes our percentage of single households served increase. Funding will be used to provide long-term leasing assistance, case management & other supportive services on an individual basis to stabilize housing. Program Outcome goals include: 90% of participants exit the program to permanent housing, 20% increase earned income & 35% increase other income. Due to the permanent nature of this program, we don't anticipate many exits this contract year.


