While the current renewal project began on 3/1/23, the contract with HUD was fully executed on 5/24/2023 due to a unexpected delay in issues and conditions.

4a. If HUD recaptured funds provide an explanation.

The main reason funds remained available were due to low unit utilization as follows: Eighty-one percent or nine participants exited the program to permanent housing during this grant period. Nine out of the eleven participants who exited the program were assessed to be move-on-ready. Eight of the nine move-on-ready participants transition to an Emergency Housing Voucher (EHV). As a result, we experienced a loss of long-term partnerships with landlords because participants transitioning into the EHV Program remained in those units. Additionally, the process of enrolling eleven new people into the program took time because new landlords were identified had significant tenant screening processes. These screening processes created delays to lease up, that caused extended time between program enrollment and the move-in date.

3B. Project Description

This Project will serve 10 households over the term of the grant. The target populations to be served include single individuals living with a disability that are not determined to be chronically homeless. Ninety-five percent of participants will come directly from shelters and five percent from the streets or other places not meant for human habitation.

The project will use a Housing First approach as evidenced by having no barriers to program entry, programming that is not contingent on participation in services and rehousing participants in the event of an eviction while in the program.

To address housing needs, we maintain our established relationships with landlords to ensure that units are available. The leasing budgets are monitored monthly to ensure timely spend down of funds. Funding will be used to lease 10 units of scattered-site apartments with 10 bedrooms at any point in time and supportive services that includes 1 FTE case manager focused on teaching needed skills to stabilize housing and income, .30 supervision, .12 FTE moving assistance,food,and transportation.

Other direct services that address the identified needs of the target populations served are housing search/counseling, life skills training, mental health services, substance abuse treatment and transportation. Non-partner agencies provide child care, education services, employment assistance/job training, legal aid, outpatient health services and utility deposits as needed.

The program projects that seventy-five percent of participants exiting the program will achieve housing stability, fifty-four percent of participants will maintain or increase earned income, and fifty-four percent of people will increase or maintain total income.

Our Local CoC, The Emergency Services Network of Kenosha County has met since 1986 as a community effort to coordinate services, share information, attract funding and eliminate duplication/service gaps for low-income people. There are 35 entities represented. Our agency chairs the local CoC Coordinated Assessment System that meets monthly to review program capacity, referrals, system functioning and improvements. We believe that HUD COC support is a vital extension to our system that strengthens the work we do, allows us to provide comprehensive services and holds us accountable to implementing the HEARTH Act that guides us towards our goal to end homelessness.

Coc funding is required for the project to operate at full capacity and meet the current need of the community according to our Prioritization Lists. Without the COC funding we would only be able to support a case manager at .49 percent FTE and would not have funding for rental assistance.



This Memorandum of Understanding (MOU) is entered into by Kenosha Human Development Services, Inc. and Kenosha County Department of Human Services, Division of Aging and Disability Services and the Division of Children and Family Services. The purpose of this MOU is to set forth the services to be provided by the KHDS Community Intervention Center, and Community Recovery Services under contract with the Kenosha County Department of Human Services, Division of Aging and Disability Services, and Professional Services Group under contract with the Division of Children and Family Services and the value of which will be used to satisfy the match requirement of the U.S. Department of Housing and Urban Development's Continuum of Care (CoC) Program.

As a match to the MyHOME Rapid Rehousing Project-WI0221L5I002204, the Kenosha County Department of Human Services, Division of Aging and Disability Services under contract with Kenosha Human Development Services, Inc. commits the following mental health services: Crisis Intervention, the Community Support Program, Crisis Case Management, KARE Center, and the Court Liaison Program. The Kenosha County Department of Human Services, Division of Children and Family Services under contract with Professional Services Group and KHDS commits mental health services through Comprehensive Community Services. Services are based on an average rate of \$59.64 per hour and the KARE Center is based on an average rate of \$77.26 per hour. The value of the services is dependent on the services used by program participants and is estimated at \$20,000 not to exceed \$37,000 for the year.

The mental health services will be available beginning <u>March 1, 2024</u> through <u>February 29, 2025</u>. The mental health services will be provided to eligible participants of the HUD CoC program on an as needed basis and hours of services will be documented in order to fulfill recordkeeping requirements of the CoC Program.
