A Self-Sufficiency Matrix is used to identify individuals strengths and barriers that may have kept individuals from obtaining or maintaining housing in the past. Success coaches assist each individual to eliminate these barriers so clients can maintain housing in this program. Supportive Services that may be offered but are not limited to are SOAR, mental health, physical health, employment and training, referrals to Golden House for DV. SC uses this matrix to help the client identify goals and objectives to work toward to increase income to obtain self-sufficiency. SC will make the appropriate referrals to other service providers so clients can access other resources available in the community. SC can transport clients to appointments, if necessary, or a bus pass can be given. Newcap is an active partner member of the BCHHC. This project will serve 60 chronically homeless individuals. This project will have an 80% retention rate. Newcap will pay the security deposit and the entire contract rent each month to the and landlord. The client will be 30% of the household income back to Newcap each month. If the household has 0 income, they will own nothing for those months. Individuals that are eligible for this project will be prioritized by length of time homeless & need according to the VI-SPDAT. The WIBOSCOC support is needed for technical assistance and guidance in the program administration.
