West CAP had a lot of staff turnover and now has several new staff trained and up to full caseloads. It was difficult with the housing market due to many people selling homes and deciding to rent for a while instead of buy, which then limited housing available for our program. Landlords have also been charging over Fair Market Rent for units and do not want to lower rent to take a client on our program when they can get more money from private renters.

This PSH project will continue to serve individuals/families experiencing chronic homelessness. Using coordinated entry, households (HHs) are prioritized for PSH in accordance with WI BOSCOG prioritization standards & HUD Notice CPD-16-011, i.e. those with the longest LOH are prioritized. Many HHs prioritized for PSH are single adults and we have seen an increase in dual diagnosis. Most commonly mental illness and AODA. Identified barriers to housing stability for this population include: AODA, mental illness, criminal drug charges, lack of public transportation and limited jobs that provide a living wage for people without a degree.

The project follows a Housing 1st model and enrolls Chronically Homeless participants without preconditions. The Housing Coordinator (HC) and Case Managers (CM) help participants find suitable housing near community amenities, handicapped accessible units as needed, ensure rents meet FMR & Rent Reasonableness, & ensure units meet HQS. HC/CMs negotiate with landlords to include utilities in rent. For units that do not include utilities, we pay directly. We hold the lease and pay full rent to LL. Participants sublease the unit from us and pay rent equal to 30% of their adj. gross monthly income.

Once housed, case managers and participants assess barriers to maintain housing, develop housing stability plan, determine frequency of visits (min. weekly), and find community resources to which the individual/family may be referred. Based on needs, CMs will connect to all appropriate mainstream resources and assist in maintaining eligibility throughout PSH, including rides to appts. CMs can assist participants with life skills, food, transportation to work, medical, AODA and mental health appts, job readiness skills, and education attainment. CMs can assist w/ SSI/SSDI apps.

CMs help participants obtain, maintain, understand and use health insurance benefits. As available, we coordinate with County CCS for wrap-around services. We refer participants to other agencies for childcare asst, ed services, employment, legal, outpatient health, AODA, and mental health services (incl DV counseling). CMs use a harm reduction approach to help HHs maintain housing. If HH is at risk of eviction, we help find a new unit and assist with moving costs. Termination from the program is rare and limited to severe breaches of participation agreement or violence against staff.

As a scattered site project we help participants transition in place at the end of their program. This maintains housing stability and connection to community resources. We have 30 HHs enrolled in PSH at max capacity. We project 85% of participants will exit to, or remain in PH. We project 67% of participants will increase total income. This will be accomplished through assisting participants in obtaining SSI/SSDI & securing job supports. HUD & WI BOSCOG support is essential in ending chronic homelessness in our area. HHs experiencing homelessness in our area have many challenges. We lack subsidized housing and long-term supports for people with MI &/or AODA. This project provides intense CM and supportive services to help households obtain and maintain permanent housing.

- Housing Navigation. Grant funds can be used to pay staff time necessary to identify safe units and facilitate moves into housing for survivors through emergency transfer(s).
- Technology to make an available unit safe. Grant funds can be used to pay for technology that the individual believes is needed to make the unit safe, including but not limited to doorbell cameras, security systems, phone, and internet service when necessary to support security systems for the unit, etc.

- Monitoring and evaluating compliance.
- Developing and implementing strategies for corrective actions and remedies to ensure compliance.

- Reporting to CoC Collaborative Applicant, HUD, and other interested parties on compliance with VAWA confidentiality requirements.
- Costs for establishing methodology to protect survivor information.
- Staff time associated with maintaining adherence to VAWA confidentiality requirements.
